CCA EDUCATION FUND APPLICATION INSTRUCTIONS - 2021

The CALGARY CONSTRUCTION ASSOCIATION EDUCATION FUND was a project initiated by the Calgary Construction Association in 1998, in response to an increasing need to provide scholarships, bursaries and prizes to high school students enrolled in building construction courses and college students enrolled in construction trades courses. A dedicated group of Calgary Construction Association Members set out to establish an ambitious and comprehensive program for collecting voluntary contributions from industry, which would be invested in a trust fund in order to generate funds each year and be distributed to high school students and college students enrolled in construction trades courses.

WHEN TO APPLY

Applications will be accepted between January 28th and April 6th, 2021. Please note we are unable to process late applications.

ELIGIBILITY

Applicants must be:

1a) Dependents of a Calgary Construction Association Member

OR

1b) Employees of Calgary Construction Association Member Companies

AND

2) Pursuing trade or technical post-secondary education

HOW TO APPLY

The application form is available via the CCA website at www.cgyc.ca under “Education” / “Scholarships”.

Application forms must be filled out completely and signed by a representative of a CCA member company.

Applications will be reviewed by the Education Fund Trustees and assessed via a rating system. Successful applicants will be notified by April 6th, 2021. Please note that only successful applicants will be notified.
