Re: Updates to the process for small site ESC Authorizations

In an effort to continuously improve our ESC program and customer service, The City of Calgary is changing the process for ESC Authorizations for sites between 0.4ha and 2.0ha and introducing an ESC Code of Practice that formalizes these updates.

Starting May 8, these sites will require a Written Notice with their ESC Plan. The City will review the Written Notice, and if it is complete, will respond with a Notice to Proceed within seven business days.

This change will streamline the process for sites 0.4ha to 2.0ha, eliminating FIR letters and resubmissions, and will also allow more time for review and support of plans greater than 2.0ha.

Applications for sites under 2.0ha submitted on May 8 will be reviewed by May 16. Applications received before this date will follow the current application procedure, so we encourage you to hold submission of these applications until May 8 unless you plan to start construction before May 16.

Please note, you must still complete a full ESC Plan in accordance with the *Instruction Manual for Erosion and Sediment Control in Calgary* and submit it with your Written Notice. Although the Plan will not be reviewed at the time of submission, it may be subject to audit later.

** ESC Plan is submitted with Written notice and is filed and not reviewed unless audited.

Why are we doing this?

We heard from our industry partners that review times are long and too few applications are approved on initial submission, resulting in construction delays.

With a busy construction season approaching, we are taking steps to ensure we can provide good customer service during peak times, increase the number of applications being approved on initial submission and attempt to reduce the average turnaround on ESC applications.

The decision to target sites 0.4ha to 2.0ha was a risk-based decision and is expected to reduce review timelines for approximately 40% of total applications.

What's next?

In April we will publish the *Code of Practice for Erosion and Sediment Control* and update the Application instructions, hold an Open House to go over the changes and field questions, and update our website with information on the new process. Registration information for the Open House will be added to calgary.ca/stmpp and distributed via our newsletter once it becomes available.

Following the 2023 construction season we will be conducting an industry survey. Based on the results, and continual program assessment, we will be exploring the long-term potential to expand this new process.
